



END-USER LICENSE AGREEMENT

PLEASE READ THIS LICENSE CAREFULLY BEFORE USING THIS SOFTWARE, By using this software, Licensee agrees to be bound by all terms of this License. If Licensee does not agree to the terms of this License, promptly return the unopened software and its complete packaging for a full refund.

PREAMBLE. This Licensing Agreement is entered into by and between Pennsylvania Home Inspectors Coalition, Inc. ("PHIC") as Licensor and _____ as Licensee. In consideration of the of the recitals, covenants and representations contained in this Agreement, Licensee's "*Compliance*" as such term is defined herein, and the payment of an initial annual fee of \$75 from Licensee to Licensor, the parties agree that Licensee shall have a nonexclusive license right to utilize the CD-ROM and the Software contained therein for the term of one year, subject to an automatic renewal for additional year(s) as follows:

LICENSE. In consideration of payment of the previously identified License fee, which is a portion of the price paid by Licensee, the software, including any images incorporated in or generated by the software, and data accompanying this License (the "Software") and any related documentation are licensed and expressly not sold to Licensee by Pennsylvania Home Inspectors Coalition, Inc. ("PHIC") on a nonexclusive, nontransferable and limited use and purpose of Licensee's constructing agreements between the Licensee and customers of Licensee for real estate inspection services. PHIC does not transfer title to the Software to Licensee; this License shall not be considered a "sale" of the Software. Licensee owns the CD-ROM on which the Software is recorded, but PHIC retains full and complete title to the Software on the CD-ROM and any accompanying documentation and all intellectual and industrial property rights therein. This non-exclusive and personal License gives Licensee the right to use and display this copy of the Software. Licensee must treat the Software like any other copyrighted material except that Licensee may either: (a) make one copy of the Software solely for backup or archival purposes; or (b) install and use the Software on the hard disk drive of a single computer provided Licensee keeps the original solely for backup or archival purposes. Licensee may not copy any written material that may accompany the Software.

UPDATES. Although it does not warrant nor represent, PHIC hereby expresses its intention, to consistently review the Software and undertake changes, additions and enhancements or modifications to best serve its collation members, while taking into consideration dynamics associated with the real estate inspection industry within the Commonwealth of Pennsylvania. Where updates of the Software are made, such updates will be made available to Licensees in good standing without further charge, except for postage and handling costs.

ANNUAL RENEWAL. This Licensing Agreement shall be in effect for one year from the date this Agreement is signed by both parties, and shall automatically renew for successive one year terms, unless terminated by either party in writing no less than thirty days prior to the then expiration of the present term. In the event of a renewal, Licensee shall be obligated to pay Licensor a \$45 fee for each annual renewal term thereafter.

RESTRICTIONS. The Software contains copyrighted material, trade secrets' and other proprietary material. Licensee may not re-sell, decompile, reverse engineer, disassemble or otherwise reduce the Software to a human-perceivable form. Except as provided for in this License, Licensee may not copy, network, rent, lease, or otherwise distribute the Software, nor can Licensee make the Software available by computer "bulletin boards", on-line services, on the internet, remote dial-in, or network or telecommunications links of any kind, nor can Licensee create derivative works or any other works that are based upon or derived from the Software in whole or in part. Within the terms of this License Agreement, Licensee may transfer all of the license rights to the Software to another party, provided that the original CD-ROM containing the Software, the related documentation, all copyright notices, and a copy of this license are transferred to that party, and provided that party reads and agrees to accept the terms and conditions of this License. If Licensee transfers the Software, Licensee must remove the Software from Licensee's hard disk drive and Licensee may not retain any copies of the Software for Licensee's own use. This Software is for the Licensee's commercial and non-governmental use only.

FURTHER RESTRICTIONS ON USE FOR SOFTWARE WITH PRINT FUNCTIONS. The Software provides Licensee with the ability to print text and/or images to construct an agreement for real estate property inspection services between Licensee and its customer(s); which contains PHIC's copyrighted artwork and characters. Accordingly, this License only allows, Licensee to print the text and/or images on paper only and use them as printed by the Licensee's computer's printer for direct commercial and non-governmental use; provided, that Licensee preserves all copyright notices that are included with the text and/or images as generated by the Software. This means that Licensee may, for example, use the Software to print agreements for real estate inspection services for adoption by Licensee's customers. Licensee may not, for example, use this Software to print agreements for third parties. Without limiting the

limiting the foregoing, Licensee may not use text and/or images generated by the Software in connection with any advertising or promotional materials, whether for profit or not for profit, without the prior consent in writing of PHIC. Use of text and/or images generated by the Software for any purpose not specifically allowed by this license is a violation of PHIC's copyrights, trademarks and other proprietary rights and will result in the immediate termination of this license.

TERMINATION. This license is effective until terminated by either party. Licensee may terminate this license at any time by returning the Software to PHIC or destroying the Software and all related documentation and all copies and installations thereof; whether made under the terms of this license or otherwise. This license will terminate immediately without notice from PHIC if Licensee fails to comply with any provision of this License Agreement. Upon termination, Licensee must destroy or return to PHIC the Software and related documentation and all copies thereof, whether made under the terms of this license or otherwise.

LIMITED WARRANTY AND DISCLAIMER. PHIC WARRANTS THE CD-ROM ON WHICH THE SOFTWARE IS RECORDED TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP UNDER NORMAL USE FOR A PERIOD OF NINETY (90) DAYS FROM THE DATE OF LICENSEE'S ACQUISITION AS EVIDENCED BY A COPY OF THE SALES RECEIPT OR PACKING SLIP. PHIC'S ENTIRE LIABILITY AND LICENSEE'S EXCLUSIVE REMEDY WILL BE REPLACEMENT OF THE DEFECTIVE CD-ROM(S) OR REFUND OF THE LICENSING FEE (AT PHIC'S ELECTION) UPON RETURN OF THE SOFTWARE TO PHIC WITH A COPY OF LICENSEE'S PROOF OF ACQUISITION. PHIC WILL HAVE NO RESPONSIBILITY TO REPLACE A CD-ROM DAMAGED BY ACCIDENT, ABUSE OR MISAPPLICATION. ANY IMPLIED WARRANTIES AND/OR CONDITIONS ON THE CD-ROM, INCLUDING THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE EARLIER DATE OF ACQUISITION BY LICENSEE OR DELIVERY OF THE CD-ROM. GOVERNING LAW AND SEVERABILITY. This License shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania, without giving effect to any principles of conflicts of law. If any provision of this License shall be

unlawful, void or for any reason unenforceable, then that provision shall be deemed severable from this License and shall not affect the validity and enforceability of any remaining provisions. This is the entire agreement between the parties relating to the subject matter herein and shall not be modified except in writing, signed by both parties.
